AWARDS: Rosettes will be awarded for qualifiers in Junior, Senior and Master Tests. Ribbons will be awarded for qualifiers in Introduction to Quarry.

CAMPING: 2010 RATES: \$20.00 per night for locations adjacent to hook-ups, \$10.00 per night for camping in parking lot. Please pay for camping no later than Sunday morning.

CLOTHING: Please bring weather appropriate gear - tests are run rain or shine.

ELIGIBILITY: Dogs must be six months of age or older and be registered with the American Kennel Club. Spayed and neutered dogs, dogs with Limited Registration, and dogs of an eligible breed that have been granted ILP (Indefinite Listing Privileges) are eligible to participate. The following breeds are classified as eligible to participate in earthdog tests: Dachshunds, Miniature Schnauzers, and the following Terriers: Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Glen of Imaal, Parson Russell, Lakeland, Manchester, Miniature Bull, Norfolk, Norwich, Rat, Russell, Scottish, Sealyham, Silky, Skye, Smooth Fox, Welsh, West Highland White and Wire Fox. Dogs that are blind and deaf shall not be eligible. Bitches in season shall not be eligible to enter the test. Entry fees paid for a bitch that comes in season shall not be refunded. 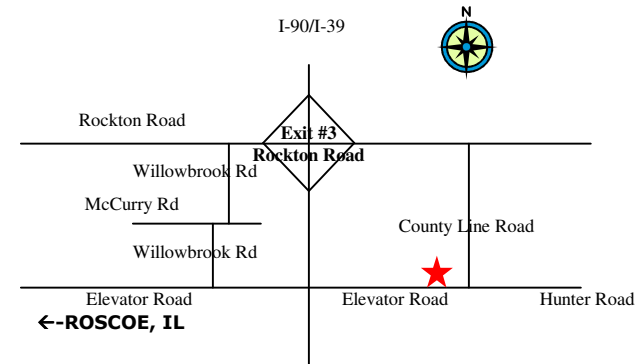
RUNNING ORDER: Dogs will be run in the order that entries are received. The test committee reserves the right to modify the running order to keep the event running smoothly.

DIRECTIONS TO THE GROUNDS

From I-39 North/South/I-90 West/East, go to Rockton Road (Exit #3). Go East on Rockton Road to County Line Road (second stop sign). Take County Line Road South to Elevator Road (first stop sign). Go West on Elevator Road .3 miles. NIBC will be on the North side of Elevator Road.

From I-43 go to Highway 140 (Exit #6). Go South on Highway 140. After about 5 miles Highway 140 curves at the State Line and becomes Highway 76. Continue for 4.5 miles to Hunter Road. Take Hunter Road to the West (right) for about 6 miles to NIBC on the North side of Elevator Road (Hunter Road becomes Elevator Road at the County Line .3 miles before NIBC).

From I-90 West take the Belvidere-Genoa Road Exit. Go North and West on Business 20 for 4 miles to Highway 76. Take Highway 76 North to Hunter Road. Take Hunter Road to the West (left) for 5 miles to NIBC on the North side of Elevator Road (Hunter Road becomes Elevator Road at the County Line .3 miles before NIBC). -or- enjoy a short cut by turning onto Caledonia Road just 1.9 miles after you head North on Highway 76. Take Caledonia Road for 9 miles until it ends at Hunter Road. Go West (left) on Hunter Road for 1.5 miles to NIBC on the North side of Elevator Road (Hunter Road becomes Elevator Road at the County Line .3 miles before NIBC).
